Diamond Sports Group CLO Exposure

This report shows the exposure for Diamond Sports Group, a subsidiary of Sinclair Broadcasting, across CLOs from the latest available monthly surveillance report as of December 6, 2021. On November 5, 2020, holdings total \$2,061 million across 780 CLOs by 89 CLO managers. Currently holdings have only dropped by a limited amount despite opportunities earlier in the year. Holdings are \$1,925 million across 717 CLO's and 80 CLO Managers.

37 CLOs have exposure greater than 1% with four larger than 2%. The three largest are Ellington CLOs. The exposure of four managers is greater than 1% with Ellington at 2.77%, more than double the next largest exposure.

Since the November 5, 2020 report, there has been extensive trading in Diamond Sports Group Term Loan (LX180415) with \$128mm of purchases and \$339mm of sales. CBAM and Blackstone were the largest sellers at average prices much greater than the current mark. Ellington is the largest purchaser (\$28mm at \$79). The current mark is \$46, while the mark on November 5, 2020 was \$70. Greater details on the holdings and trading are available on the Structured Finance Portal.


